NOTICE

This is to notify all concerned first-year (2026 batch) students that, on the basis of applications received, a total of 90 (Ninety) students have been provisionally allotted hostel rooms in C. V. Raman Hall of Residence for the session July–December 2026, and 20 (Twenty) students have been placed on the waiting list. The complete list of allotted and waitlisted students, along with room numbers, is enclosed as Annexure-1.

This allotment is **PROVISIONAL** and **NOT FINAL**. It is liable to be changed, revised, reshuffled or cancelled by the Hostel Management Committee at any time, without prior notice, on account of document verification, seat availability, administrative requirement or any other reason deemed fit. No student shall acquire any vested right to a particular room or seat merely on the basis of this list.

All students whose names appear in the allotted list (Annexure-1) are required to deposit the total hostel fee of ₹9,200/- (Rupees Nine Thousand Two Hundred only) for the session July–December 2026, comprising:

- ₹7,200/- towards hostel rent (July–December 2026, six months)
- ₹1,500/- as refundable security charge
- ₹500/- as one-time hostel registration fee

The above fee, along with the duly filled-in Hostel Registration Form (**Annexure-2**), must be submitted in Room No. 18 latest by **2nd August 2026**. Students must collect the official fee receipt after submission and retain it for future reference. Students who fail to deposit the fee and submit Annexure-2 within the stipulated period shall be deemed unwilling to avail hostel accommodation; their allotted seat shall stand forfeited and shall be offered to students on the waiting list (Annexure-1). All allotted/resident students shall be governed by the Hostel Rules and Guidelines enclosed as **Annexure-3**, and must submit a duly signed Affidavit-cum-Undertaking, **countersigned by their Parent/Guardian (Annexure-4)**, at the time of fee submission. No allotment shall be treated as confirmed without submission of the signed affidavit.

RULES & REGULATIONS FOR HOSTEL RESIDENTS

1. General Conduct

- All residents must maintain discipline and decorum within the hostel premises
- Any act of physical or verbal abuse, harassment, or bullying will result in strict action
- Residents should respect hostel staff and fellow students at all times
- **Fine: Rs. 1000 - Rs. 5000**, depending on the severity of misconduct
- Severe violations may lead to expulsion from the hostel or restriction from the institute.

2. Attendance & Curfew

- Residents must return to the hostel by **10:00 PM** (unless prior permission is granted)
- Unauthorized late entry or night-outs will attract penalties.
- **Fine: Rs. 1000 for first offense, Rs. 3000 for repeated offenses**
- Continuous violation may result in hostel expulsion

3. Cleanliness & Hygiene

- Rooms must be kept clean and organized; regular inspections will be conducted
- Waste must be disposed of in designated bins.
- **Fine: Rs. 1000** for unclean rooms or littering.
- Repeated offenses will lead to a **Rs. 3000 fine and disciplinary action**

4. Visitors & Guests

- Guests are allowed only in the common areas with prior permission.
- No guest is permitted to stay overnight.
- Unauthorized guests will result in **Rs. 2000 fine**.

5. Prohibited Activities

- **Consumption of alcohol, drugs, or smoking** inside the hostel premises is strictly prohibited.
- Any resident found indulging will face a **fine of Rs. 5000 and immediate hostel expulsion**
- Severe cases may lead to **institutional suspension or legal action**

6. Electrical Appliances & Fire Safety

- Unauthorized electrical appliances (heaters, induction stoves, etc.) are not allowed
- Fire safety regulations must be strictly followed.
- **Fine: Rs. 2000** for violations.

- Any tampering with fire safety equipment will lead to **Rs. 5000 fine and possible hostel expulsion**

7. Noise & Disturbance

- Loud music, shouting, or any form of disturbance is prohibited after **10:00 PM**
- Any violation will attract **Rs. 1000 fine**
- Repeated disturbances will lead to **Rs. 3000 fine and possible disciplinary action**

8. Damage to Property

- Any damage to hostel property (walls, furniture, electrical fittings, etc.) must be compensated
- Fine: Rs. 2000 or more, depending on damage cost**
- Deliberate damage will lead to **Rs. 5000 fine and possible hostel expulsion**

9. Unauthorized Relocation or Room Changes

- Residents must not shift or exchange rooms without prior approval
- Unauthorized relocation will result in **Rs. 3000 fine**

10. Ragging & Harassment

- Any form of ragging, mental or physical harassment, will result in **immediate hostel expulsion and possible institute restriction**
- Fine: Rs. 5000 and legal action if necessary.**

11. Theft & Unauthorized Possession

- Stealing or unauthorized possession of another resident's belongings is a **serious offense.**
- Fine: Rs. 5000 and possible hostel expulsion.**
- Severe cases may lead to **institutional suspension or legal action**

12. Reporting & Compliance

- Residents must report any suspicious or unauthorized activities
- Compliance with hostel rules is mandatory for continued residency

Note: The hostel management holds the authority to revise fines and impose stricter actions as deemed necessary.

6. That I shall be personally responsible for any loss or damage caused by me to hostel property, furniture or fixtures, and shall bear the full cost of repair or replacement thereof.
8. That I am executing this Affidavit-cum-Undertaking out of my own free will, without any coercion, threat or undue influence from any person.
